The OIPC's document, [Guidance on the Use of Automated Licence Plate Recognition Systems by Police Services](#), outlines the key obligations police services have under Ontario's public sector privacy legislation in their use of ALPR systems for public safety purposes. The guidance includes best practices for using ALPR systems in a privacy-protective manner and discusses issues, including:

- overview of ALPR technology
- privacy implications of ALPR systems
- benefits of Privacy Impact Assessments
- implementation guidelines

- b. Please provide a full description of the initiative (no more than 350 words):

In recent years, the OIPC has observed a growing interest in the use of automated licence plate recognition (ALPR) technology by police services in Ontario. We also recognized that some implementation models of ALPR technology pose significant risks to privacy.

To address this concern, we developed detailed guidance to support the implementation of ALPR systems in a privacy-protective manner, in consultation with the OPP. [Guidance on the Use of Automated Licence Plate Recognition Systems by Police Services](#) explains how an ALPR system is typically used by a police service and sets out detailed, practical and implementable guidance for police services seeking to install an ALPR system.

ALPR technologies quickly capture and match large volumes of licence plate numbers to lists of plates stored in a database. Police services in Ontario use ALPR systems to match licence plates with lists of plates, such as stolen and expired plates and plates registered to suspended drivers. These systems can also be set up to capture other information, such as the location of vehicles at specific times and dates. As a result, ALPR systems have the potential to track individuals' locations over time, facilitating surveillance and profiling of law-abiding individuals as they go about their everyday lives. The OIPC guidance highlights these privacy risks, and demonstrates the dangers of implementing an ALPR system without adequate policies, procedures and technical controls.

The document provides detailed guidance on best practices for implementing the technology, such as conducting a Privacy Impact Assessment and consulting the OIPC prior to implementing the program. It also summarizes and clarifies the key obligations of police services under Ontario's privacy legislation when using an ALPR system. These obligations include requirements related to notice, collection, retention, use, disclosure, accuracy, security and access to information requests. For example, police should only retain non-violator data briefly, and delete this data at the earliest opportunity. Other tools to mitigate privacy risks and ensure accountability are also recommended, such as conducting system reviews and audits, and staff training.

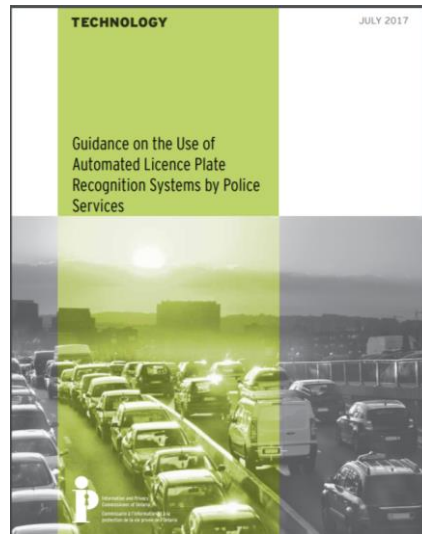
[Guidance on the Use of Automated Licence Plate Recognition Systems by Police Services](#) is the first guide of its kind in Canada and serves as a baseline for the policies and procedures for establishing ALPR systems.

The OIPC consulted with the OPP to ensure the guidance's applicability, utility, and relevance to police services across the province. Our research and consultation work began in 2015 and was completed in 2017.

Today, more than 20 police services in Ontario follow the OIPC guidance. Many Ontario police services are transparent about their use of ALPR and compliance with our guidance. For example, the London Police Service's [ALPR website](#) shares news, videos, the OIPC guide, and other general information about the system, emphasizing the service's commitment to compliance.

Lastly, many of the principles and best practices discussed in the guidance have broad application to other surveillance technologies, such as police body worn cameras and school bus stop-arm cameras.
