CNIL and Inria (French public entity for scientific research on digital sciences and technologies) reward a scientific article in the field of computer or information science dedicated to the protection of personal data or privacy and written in French or in English.

- b. Please provide a full description of the initiative (no more than 350 words):

The purpose of the Competition is to reward a computer or information science paper published in a scientific journal or in the proceedings of a national or international conference during the two civil years before the launch of the Competition. The Article, in French or in English must necessarily address the improvement of the protection of personal data or privacy. It may describe a research result, a technical innovation, a didactic presentation of the state of the art or an initiative to promote interdisciplinarity. It should be possible to convey the substance of the contribution of Article in terms accessible to non-experts.

The winners are invited at the Computers, Privacy and Data Protection conference (CPDP) in Brussels, Belgium. The winning Article is announced on the Inria and CNIL

web sites and it is presented at the CPDP Conference. A symbolic prize, such as a medal or a trophy, is awarded during the CPDP conference.

- c. Please explain why you think the initiative deserves to be recognised by an award (no more than 200 words)

It is an opportunity to raise awareness and promote research on privacy and data protection within the scientific community, quite particularly as regards the evolutions led by the General Data Protection Regulation (GDPR).  
In particular the development of Privacy by design, accountability and necessary development of technical tools allowing in particular to guarantee the security of the data and individuals rights.
