**4. Description of the initiative**

- a. Please provide a brief summary of the initiative (no more than 75 words):

The Office of the Privacy Commissioner (OPC) launched an own motion inquiry into the Ministry of Social Development's (MSD) use of its information compulsion powers. OPC found that MSD had been misusing its powers and unjustifiably intruding on the privacy of thousands of New Zealanders. OPC's inquiry resulted in widespread public reporting. MSD also agreed to change their practice to comply with their legal obligations and undertake a review of their legislation to ensure consistency with recent privacy and other human rights jurisprudence.

- b. Please provide a full description of the initiative (no more than 350 words):

OPC's inquiry found that the MSD had been unjustifiably infringing on the privacy of individuals by failing to meet their legal obligation to first ask individuals for information before seeking it from other sources. This failure led to overly broad requests for information that was oftentimes unnecessary and sensitive (eg domestic violence records, hospital notes, text messages etc).

The MSD administers New Zealand's social security regime, administering benefits to thousands of New Zealanders from superannuates to solo parents. As part of this role they are responsible for ensuring the integrity of the social security system through investigating potential instances of fraudulent activity. MSD have the power under the Social Security Act to require individuals or agencies to provide information to them for the investigation of potential benefit fraud. This power is governed by a Code of Conduct which requires that before seeking information from anyone other than the individual to whom the information relates, MSD must ask the individual for that information first. The only exception to this requirement is if requesting the information from the individual concerned would likely cause a prejudice to the maintenance of the law.

The Code of Conduct is designated an Information Privacy Code for the purposes of the Privacy Act, meaning that any breach of the Code provisions is considered a breach of the Privacy Act and able to be investigated by the Privacy Commissioner.

The Privacy Commissioner can inquire into any matter that may infringe upon the privacy of an individual. OPC launched an inquiry into MSD following a letter of concern being sent to our office by a community group. The community group stated that it was their belief that MSD were acting unlawfully by failing to ask individuals for their information before seeking it from other parties, including telecommunications companies, banks, hospitals and the Police. OPC felt that the concerns raised were so serious and potentially affected so many individuals that it was a matter of importance for the Commissioner to inquire into.

Following OPC's inquiry MSD changed its practices to comply with its legal obligations, it also agreed to review its legislation in light of relevant human rights jurisprudence that had developed since the law was enacted in 1964. OPC is continuing to monitor MSD's progress on this issue but has seen positive change in the two months following the inquiry reports release.

- c. Please explain why you think the initiative deserves to be recognised by an award (no more than 200 words)

MSD's failure to act consistently with their legal requirements affected vulnerable members of New Zealand society - those reliant on the state for support and assistance. OPC's inquiry gave a voice to those affected by MSD's failures and affected positive change for them.

OPC successfully brought about this change despite only having recommendatory powers, demonstrating OPC's ability to successfully influence government through persuasive reporting.
